Attention: Simcoe County Council Members

Dear Councilors,

This is a follow-up to my letter dated December 5, 2020, in which I asked you to investigate the pandemic state of emergency declared in March 2020.

It is now eighteen months after the start of the pandemic response, and nine months after my letter, and the situation has become clearer.

The key points made in my December letter still stand:

- ★ PCR tests cannot diagnose infectious disease and are being misused. Results from the tests can be easily manipulated by adjusting the cycle threshold (CT) to achieve false positives (CT > 24).
- ★ The social impacts of lockdowns (job loss, housing instability, social isolation, etc.) have been worse than the impacts of COVID illness.
- ★ The vaccines are experimental and high risk.
- ★ Too many people are benefiting from the pandemic hindering cessation.

New Information

Today new information that is critical to Canadians is available.

Dr. Reiner Füllmich, a lawyer registered in Germany and California, is famous for spearheading litigation against big multi-nationals Volkswagen (das liar scandal) and Deutsche Bank. He is Chair of the *Stiftung Corona Ausschuss Investigative Corona Committee Germany*, a group founded with the mandate to identify why federal and state governments imposed unprecedented restrictions as part of the coronavirus response and what the consequences have been and still are for the people.

To summarize the video in a nutshell, Dr. Füllmich's team confirmed the following about the COVID-19 pandemic:

- the pandemic occurred due to governments and mainstream media deliberately spreading panic with targeted fear mongering [mark 1:12]

 - despite no excess mortality anywhere [2:05]
 - partly staged and partly based on gross medical malpractice [2:10]
 - *summary of the Corona Committee's work to-date* [3:09]
 - COVID measures are not about health [4:20]
 - governments are not acting in the best interest of their people [4:50]
 - governments are largely under control of the backers of global corporations and NGOs aka "Mr. Global" [5:00]
 - *global corporations are beyond the law* [5:05]
 - PCR test is not approved for diagnostic purposes [8:10]
 - COVID measures cause very serious damage to the health of children, with incalculable long-term consequences [8:27]
 - safety and efficacy of COVID injections not backed up by any scientific or medical studies [10:25]
 - *COVID measures were never about health; gain of function; bioweapons* [12:30]
 - the original virus has long ceased to exist; mutations are less dangerous; doubts that the virus was scientifically isolated; suspicions that flu virus was relabeled COVID [13:19]

Mainstream Media

The above new information may come as a surprise to you and that would be understandable.

People who listen to government and mainstream sources alone will have heard another totally different narrative. A scripted narrative. As Dr. Füllmich says "the governments and mainstream media deliberately spread panic ... this was done by a world-wide lockstep approach of continuously blasting out the alleged danger of the alleged new virus via the mainstream media." [mark 1:10]

Mainstream and key social media services are easily censored and controlled. See Appendix A.

My Concerns

I realize that as the messenger I run the risk of being decapitated but the predicament we are in is too dire to keep silent.

I have spent roughly 50 hours per week for the past 18 months researching away from the mainstream and I support everything that Dr. Füllmich says.

Please keep an open mind and take my concerns into consideration.

1. "Vaccines" - the injections do not meet the legal or medical definition of a vaccine. They are, in fact, experimental gene therapy. The injections have been authorized for human use under emergency use / interim order and have not been medically approved as they are still in clinical trials until 2023. The lists of ingredients have not been made available and the ingredients are subject to change until approved. See Appendix D for known side effects. Many doctors are warning that the vaccines are de facto bioweapons and will kill their recipients via pathogenic priming / antibody dependent enhancement (ADE) when next exposed to a coronavirus.
2. Injecting Children – the chance of a child dying from COVID is statistically zero (see Appendix C). The risk from the injections is much greater (see Appendix D). Additionally, doctors are warning that children's reproductive systems may be negatively affected and there is a definite risk of heart problems in young males¹.
3. Coercion and Lack of Informed Consent – people are being coerced to accept the shots and "do the right thing" by governments and mainstream media despite unreliable vaccine-immunity and even though natural immunity is durable and robust. Lately people's jobs² and freedoms are being put on the line. Yet, recipients are not being told that they will be clinical trial participants or what risks they are taking. Furthermore employers do not realize that enforcing such mandates gives them the liability for employee injury and charges of battery. This is not "the right thing".
4. Vaccine Passport – Canadians already have immunization records in the form of a yellow card. Yet the federal government has established a \$1 billion fund³ to finance online vaccine tracking. Such a system would be the forerunner to a Chinese-style social credit system and is

undoubtedly a key deliverable of the plandemic narrative. As Canadians, do we want to show our "papers" everywhere we go until there are cameras every metre⁴?

5. Segregation – the COVID narrative has focused on divisiveness: lockdowns and isolation, old vs young, employed vs unemployed, vaxxed vs unvaxxed, employers vs employees, schools vs students, citizens vs police, sheep vs conspiracy theorists. There are many labels and a lot of hype, which is a tried-and-true divide and conquer strategy. We need to come together as a community.
6. Concentration Camps – the federal government has organized and is building "safe voluntary isolation sites"⁵ with little explanation and a lot of secrecy. This does not bode well.
7. Never-ending Story – there is no end in sight. Israel is mandating a 3rd "booster" and talking about a 4th. Canada's federal government has ordered 8 doses per person into 2024⁶. The current definition of "fully vaccinated" is two doses plus 14 days, which will necessarily be redefined when another shot is required. In other words, people with 2 shots will return to "unvaccinated" when it comes to a 3rd and subsequent shots. This will ensure that any vaccine injuries from the first shots will be hospitalized and hyped as "unvaxxed" in the media creating a self-feeding cycle of variants and boosters.

Please do not allow the vaccine passports in whatever form it takes.


Please do not allow our children to be harmed – they do not need masks, isolation, and experimental injections.
